

Privacy Information Statement – Microsoft 365 Copilot Paid with Enterprise Data Protection

What is a Privacy Information Statement?

When a digital service or application is utilised as part of the teaching and learning curriculum, we require your consent to allow collection, use and disclosure of your child's personal information including when data is transferred and held in cloud-based storage offshore, outside Australia. The following Privacy Information Statement provides information about the application to allow informed consent to be provided.

What is Microsoft 365 Copilot Paid with Enterprise Data Protection?

Microsoft 365 Copilot Paid with Enterprise Data Protection (M365 Copilot Paid with EDP) is a generative Artificial Intelligence tool integrated into the Department of Education and Training's, M365 environment. M365 Copilot uses Azure OpenAI's large language models (LLMs) to enhance productivity in applications, apps like Teams, Word, Excel, PowerPoint and Outlook. It assists tasks such as summarising content, generating text or images such as JPEG format, and retrieving relevant information. By drawing on data users already have access to, such as emails, chats, meetings, documents, and contacts, M365 Copilot provides contextual, AI-generated responses.

What data is collected?

M365 Copilot Paid with EDP does not require separate account registration. Instead, it uses existing M365 user account details and organisational directory information managed through Entra ID to authenticate users and determine access permissions. To provide its services, M365 Copilot may, at times, collect and process certain personal information from users and their work-related content. The service does not collect new data or access public websites, social media, or third-party apps. All processing happens in real time within Microsoft's secure environment, respecting user privacy, permissions, and data residency rules. M365 Copilot does not store user interactions or use them to train its models, ensuring that all activity remains private and temporary.

How is the data used?

Microsoft states that Copilot operates entirely within the department's secure M365 environment and follows existing user access controls. When a user interacts with M365 Copilot, any data involved such as prompts, responses, and related content like documents or emails is processed and stored securely within the department's system. This data is encrypted, only accessible to authorised

users, and is not used to train the AI models behind Copilot. This means that any information entered into Copilot remains private and will not be reused or shared with other users.

Is the data secure?

M365 Copilot Paid with EDP operates within the department's secure environment and follows existing user permissions managed through Entra ID, ensuring it only accesses information users are already authorised to view. School-based administrators can manage access based on user roles, helping protect data privacy and control features like file sharing and chat. M365 Copilot Paid with EDP does not connect to the department's core systems such as Compass, Xuno, GradeXpert, or TRM, so it cannot access sensitive student or staff records. A security assessment has been conducted to confirm that M365 Copilot meets the department's technical security standards.

Who has access to the data?

Only authorised users such as staff and students with appropriate permissions can access the data. All information remains private, encrypted, and accessible only to those with approved access.

When is the data deleted?

Microsoft provides strong data retention and deletion tools that help protect personal information. Data is only kept for a limited time, usually between 30 and 180 days depending on the type and purpose. Schools can set rules to automatically delete or keep data as needed. Once data is no longer required, Microsoft ensures it is permanently deleted and cannot be recovered. If needed, specific user data can also be permanently deleted using secure processes.

Where is the data?

The M365 Copilot tenancy is in Australia.
