

# Privacy Information Statement – Kahoot! for schools

---

## What is a Privacy Information Statement?

When a digital service or application is utilised as part of the teaching and learning curriculum, we require your consent to allow collection, use and disclosure of your child's personal information including when data is transferred and held in cloud-based storage offshore, outside Australia. The following Privacy Information Statement provides information about the application to allow informed consent to be provided.

## What is Kahoot! for schools?

Kahoot! for schools is designed as an all-in-one engagement service to allow teachers to create interactive content and experiences which can be hosted live and assigned to students. Students can join on any device, in-person virtually or in a hybrid learning environment which can be accessed through a simple QR code or game pin. Lessons designed as interactive experiences can motivate students to actively participate in learning, through incorporated challenges, rewards and competition that can reinforce learning and knowledge retention.

## What data is collected?

Teacher name, email and school information is collected on registration. Students' names, class and year level is collected for usage of the service. Kahoot! for schools records evidence of student interactions to provide student data results for teachers. Usage and cookies data is collected whenever there is interaction with this service.

## How is the data used?

Personal information collected is required to access the service and for responding to queries logged by teachers during the use of the service. Teachers have the option of using an anonymous nickname for students when registering accounts.

## Is the data secure?

Kahoot! for schools state they maintain a comprehensive security program designed to protect the security, privacy, confidentiality, and integrity of personal information held within their organisation. Kahoot! for schools have a separate privacy policy for students and state they only

collect and use student personal information as necessary for authorised school purposes.

## Who has access to the data?

School staff and students as participants, when using Kahoot! for schools teachers are able to interact and track individual students progress over time and also enable the students to share information with other students in the same class or school. Employees of the company and third-party service providers who provide technical services in protecting and securing the systems and other business-related functions. Kahoot! for schools state they do not share or sell student data for marketing purposes.

## When is the data deleted?

Kahoot! for schools state they do not retain any personal information any longer than necessary for the purposes for which it has been collected. Data can be deleted on termination of an account, or when notified by the school to delete all data.

## Where is the data?

Data is hosted mainly via Amazon Website Services and Google Cloud in the United States of America and the European Union with backup servers in Australia.
