Privacy Information Statement - Brightpath Progress

What is a Privacy Information Statement?

When a digital service or application is utilised as part of the teaching and learning curriculum, we require your consent to allow collection, use and disclosure of your child's personal information including when data is transferred and held in cloud-based storage offshore, outside Australia. What data is collected?

Personal data collected for use of this application is the teacher's name and email and class name. Student full name, date of birth, year level, class name and email are captured.

How is the data used?

Information collected from staff and students will be used to provide the primary service of the application which includes: the Registrant, staff, receiving newsletters or emails to administer and manage accounts, publish names of winners and high performers and to provide result data to schools.

Is the data secure?

3P Learning Limited state they handle all personal data collected securely and have implemented appropriate technical administrative and physical security measures that are designed to protect personal information from unauthorised access, disclosure, use or modification through encryption and other organisational measures. 3P Learning Limited have representation in Australia and adhere to the Australian Government Privacy Principles.

Who has access to the data?

School staff and employees of 3P Learning Limited, and any third-party provider contracted by 3P Learning Limited as a service provider. At times 3P Learning Limited may provide data on results to government education departments, peak bodies or schools requesting performance reporting data, adhering to strict instructions on use of any information provided, i.e., educational interests only.

When is the data deleted?

Brightpath Progress states it keeps personal information for the duration of the relevant subscription. Once the subscription has come to an end all data is destroyed or de-identified upon receiving written consent from the school. An irreversible data anonymisation process is completed upon requests. Schools are responsible to contact 3P Learning Limited to request deletion of personal information of exiting students or when no longer required at privacy@3plearning.com.
